

Dear Provider,

As we are approaching the end of the year, please take the opportunity to schedule all of your senior members to come in to complete an annual wellness and close any HEDIS preventive quality measure. This is very important in keeping members healthy and to manage any chronic condition(s) the members may have. As a reminder, St. Vincent IPA utilizes a population management system called **Cozeva** to provide our network with a tool to manage and care for the health of our members. Primary Care Providers can utilize Cozeva to submit care gap reports as well as annual wellness visit forms directly to St. Vincent IPA in real time, thus eliminating the need for faxing and potentially delaying the process. If you and your staff have not obtained access to Cozeva, please reach out to jmarquez@pdtrust.com for obtain access.



Care gap report and members pending annual wellness were sent to your office back in May. These lists can also be accessed through the Cozeva portal.
